ZOGG FIRE EVACUATION UPDATE – Shasta County

WHAT: **Re-entry:** Repopulation of South Fork Road, Rainbow Lake Road, Buell Road , Duncan Creek Road, Bully Choop Road, and Old Bully Choop Road

WHEN: 10/5/2020 @ 10:00am

WHERE: Shasta County

ORDER: Opening of areas in Shasta County

Traffic Control Points/Road Closure:

- Zogg Mine Road @ South Fork Road
- Rainbow Lake @ Sunny Hill Rd.

Evacuation orders have been lifted and repopulation is in effect for residents and roadways off of South Fork Rd to include; Archer Rd, Ella Richter Rd, Bender Rd, Berry Patch Ln. and Burger Rd. Zogg Mine Rd and all roads off of Zogg Mine Rd. are still closed. A road closure on South Fork Road will remain in effect for a 24 hour period for all residents accessing their property via South Fork Rd. All residents entering this area will be required to provide identification and proof of residency. An evacuation order and road closure will remain in effect for all roadways and residences on Zogg Mine Road. Fire suppression, utility restoration efforts and hazard mitigation is still active on the roadways.

Evacuation orders have been lifted and repopulation is in effect for residents only on Rainbow Lake Road west from the intersection of Platina Road to the intersection of Rainbow Lake Road at Sunny Hill Road. Sunny Hill Road and all roadways west of this intersection will remain closed and under mandatory evacuation order. The road closure on Rainbow Lake Road at Platina Road will remain in effect for a 24 hour period and will be open to residents only. All residents entering this area will be required to provide identification and proof of residency. Fire suppression, utility restoration efforts and hazard mitigation is still active on the roadways.

Evacuation orders have been lifted and repopulation is in effect for residents only on Buell Road and adjoining roadways. The road closure on Buell Road at Platina Road will remain in effect for a 24 hour period and will be open to residents only. All residents entering this area will be required to provide identification and proof of residency.

Evacuation orders have been lifted and repopulation is in effect for residents on Duncan Creek Road, Bully Choop Road and Old Bully Choop Road. All of Platina Road is open east from Highway 36 to the intersection of Placer Road and Gas Point Road

NOTES : SAFETY MESSAGE – The public is reminded to stay vigilant on current fire conditions. Please continue to adhere to road closures and any evacuation warnings. A reminder to drive slowly and yield to emergency personnel in the area. There will be smoke in the respective areas as firefighters continue firefighting operations.
